
Community Pharmacists & CKD Care During COVID-19

The coronavirus pandemic arrived almost three years ago and killed millions worldwide. The first two coronavirus disease (COVID-19) deaths in the United States were chronic kidney disease (CKD) patients. Casualties continued to increase (amongst such patients) during the first several months of the pandemic. According to the Center of Disease Control and Prevention, 50% of dialysis patients who got Covid-19 were hospitalized, and 20-30% of hospitalized dialysis patients with Covid-19 died.

Dialysis patients and patients who received a kidney transplant also have a weaker immune system and are at higher risk of contracting COVID-19. Additionally, patients with no known underlying kidney disease started to show acute kidney injury when hospitalized with COVID -19. These reports supported the clinical findings that COVID-19 infection affected the kidneys and increased the deterioration of renal function faster in CKD patients.

No one currently knows why COVID-19 infection may be affecting individuals differently. Since 2019, researchers, doctors, and clinicians have scrambled to decipher the COVID-19 mechanism of action. Understanding these mechanisms would allow for treating future subvariants with effective COVID-19 vaccines and oral therapies.



Proposed factors that may explain why COVID-19 affects CKD patients significantly more than other patients

with different pathologies:

- 1. COVID-19 viruses are highly expressed in ACE or DPP4 receptors of the renal tubules, where they can attach, multiply, invade and damage kidney tissues.
- 2. COVID-19 viruses could damage surrounding vasculature areas, and abnormally low oxygen levels are transported to the kidneys.

- 3. Covid-19 can cause small clots to form in the veins and small arteries to block the kidneys from performing their function.
- 4. Covid-19 not only causes kidneys to malfunction but can also produce inflammatory cytokine storms, which can destroy healthy kidneys.

5. Covid-19 infections attack CKD patients much more readily, especially those taking glucocorti-

coids and immunosuppressant medications.

The global pandemic strained our healthcare system to the point where we have seen chronic shortages of healthcare professionals in hospitals and community settings and backlogs in supply chains. As a result, this created tremendous stress and challenges for everyone. The continual care of CKD

patients is critical, and fortunately, community pharmacists are the most accessible health care professionals.

During the onset of Covid-19, community pharmacists' role expanded beyond dispensing medications. Today they play a much more active role in patient care. As part of their responsibilities, pharmacists are highly trained to assist CKD patients by reviewing their list of medications, identifying potential drug-drug interactions, educating them on risk factors, and following up on therapeutic drug monitoring and pharmacotherapy. Community pharmacists also assist CKD patients in better understanding their medications, counseling, identifying potential side effects, and promoting medication adherence. Patients actively involved in their treatment remained healthy amidst the Covid-19 pandemic as they were better informed about controlling their disease.

Pharmacies have expanded their services to home delivery of medications, critical supplies, necessary protective items, and telehealth to pharmacists providing patient care services. Community pharmacists have also assisted in screening, point of-care testing, dispensing Covid-19 test kits,

and administering Covid-19 vaccines to CKD patients. The benefits of the Covid-19 vaccine to CKD patients far outweigh the risk of contracting Covid-19. If they are concerned about their safety, CKD patients should talk with their physicians, pharmacists, or other healthcare professionals about the Covid-19 vaccines.

Although Covid-19 has been challenging for CKD patients, community pharmacists' service has helped manage CKD patients with medication usage, safety, and adherence. Pharmacists' involvement as one of the frontline healthcare professionals during Covid-19 has reshaped the pharmacists' role in managing CKD and emerging infectious diseases and health crises.

The Early Bird Gets the Worm! Did you know...

that you may sign up for a kidney transplant BEFORE you go on dialysis? When your



Glomerular Filtration Rate (GFR) drops to 20 or below, you are eligible to get onto a transplant list. Dialysis often is not initiated until you are symptomatic (GFR 8-10 ml/min). A transplant (from either a living or deceased donor) before dialysis is called a pre-emptive transplant; you

should aim for that. To sign up for a kidney transplant, ask your Nephrologist to refer you to the transplant center of your choice. Remember each transplant center has it own set of guidelines. If you are rejected by Hospital A, try Hospital B or then C. GOOD LUCK!

Annual Enrollment Review Your Medical Insurance: It's That Time of Year Again!

Once a year, you are allowed to change your insurance selections. If you belong to Medicare, Annual Enrollment is when you can join or change your stand-alone Part D prescription drug plan or Medicare Advantage plan for the next year. Medicare and HICAP (Health Insurance Counseling and Advocacy Program) strongly recommend reviewing your prescription drug plan or Medicare Advantage Plan every year. You could save money, get better coverage, or both.

New prescription drug and health plan choices are offered every year. Moreover, plans can change their list of covered drugs, provider networks, benefits, copays, and more. Your needs may have changed too. You may be treated for a new condition or take a new medication that a different plan may more optimally cover. According to a recent Forbes article, 90% of those surveyed were not in the most cost-effect Medicare plan for their prescriptions. Don't be caught off guard when you go to the pharmacy or doctor next year and find that your drug or service isn't covered or has a higher copay!

Medicare annual enrollment for coverage in 2023 starts on Tuesday, October 15, 2022, and ends on Saturday, December 7, 2022. You can enroll in Medi-Cal year-round.

Contact your local HICAP office for free help in evaluating your options. Go to https://cahealthadvocates.org/hicap/ and select your county for specific web addresses and telephone numbers.

Suppose you are under 65 and have Covered California. In that case, you can apply for a health plan outside of open enrollment (or make changes to your current policy) if you experienced one of these qualifying events (usually within the first 60 days).



Qualifying life events are:

Lost job or income Turned 26 years old or 65 years old Married or entered a domestic partnership Lost health insurance

Lifesaving and Free but COVID Medication Goes Begging

Yes, **Evusheld** is free to eligible patients! It is a medication that can prevent SARS-CoV-2, COVID) infections in high-risk patients, but only 25% of the nationwide supply of 1.7 million doses have been used.

At least 7 million people are immunocompromised or immunosuppressed, including cancer patients

and other patients who are allergic to COVID-19 vaccines.

The **Evusheld** medication consists of laboratory-produced monoclonal antibodies against COVID, reducing infection risk by 77%. Evusheld (AZD7442) is a combination of two long-



acting antibodies (tixagevimab and cilgavimab) is administered by intramuscular (IM) injection.

Dorry Seqev, M.D., Ph.D., transplant surgeon at Johns Hopkins University, refers to a recent publication that states: "the transplant patient has 82 times higher risk of breakthrough-infection than people in the general population." Let me introduce to you Walt Umbach...



Medicare and ESRD: What You Need to Know

In this webinar, you will learn how Medicare and End Stage Renal Disease work together. If you have ESRD, you can get Medicare no matter what age you are if all of these apply:

- Your kidneys no longer work;
- You need regular dialysis or have had a kidney transplant; or
- One of these applies to you:
 - You've worked the required amount of time under Social Security, the Railroad Retirement Board (RRB), or as a government employee;

- You're already getting or are eligible for Social Security or Railroad Retirement benefits;
- You are the spouse or dependent child of a person who meets either of the requirements listed above.
